- Ranked Choice Voting enhancements for Berkeley, Oakland, and San Leandro
- Allows voters to rank candidates in order of preference
- RCV is approved for use in the cities of Berkeley, Oakland, and San Leandro
- ROV's RCV practice tool in 5 languages on our website (for voters to practice RCV voting)
- 9 Vote Centers, 18 Drop Box Locations
- Voted in person on Election Day = 4,542
- Vote by Mail Voter Participants = 90,466
- Total number of ballots cast = 95,008
